AMENDMENTS TO SOLICITATION (MODIFIED) (a) The Solicitation may be amended at any time prior to opening. (c) If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.

PERFORMANCE BOND REQUIRED (JAN 2006):

Within ten (10) days after award, contractor shall provide a performance bond in the full amount of the contract sum, issued by a surety company licensed in South Carolina, with an "A" minimum rating of performance as stated in the most current publication of "Best's key rating guide, property liability" which shall show a financial strength rating of at least five (5) times the contract amount. Each bond must be accompanied by a "power of attorney" authorizing the attorney-in-fact to bind the surety and certified to include the date of the performance bond. [07-7B155-1]

The following changes or additions to the scope of work:

- 1. Painting of concrete and block walls should include walls beneath stairs, particularly at entrance to Spark Center.
- 2. Dock levelers to be painted black (not yellow).
- 3. The fire pump building and the chiller building need to be painted. They are marked on the revised map drawing attached.
- 4. The guard shack at the entrance to the tractor trailer area off of Hwy 290 needs to be painted SW 9162 African Gray (not the brick, just the metal). This building is not visible on the drawing.
- 5. Paint all hand rails SW 7075 Web Gray.
- 6. Paint two small awnings blue SW 6531 Indigo at BMW Building.

Question received:

- Q. We need to know if the tank that is approx.. 40' high and 135' round gets painted?
- A. No, the large water tank does not get painted.
