Amendment No. 1

Questions and Answers:

1. Is this a 24'x36' box or 24'x32' box.
(A) This is a 36' x 24' classroom (32' x 24' box)
2. What type of permitting are you requiring bidders to secure? Will owner procure building permit?
(A) The successful contractor will secure any/all applicable and required permits, including a building permit if it is required by Cherokee County for this work.
3. Do the Hitches, Tires, wheels and axles remain with the building?
(A) Yes. Skirting is required, and the owner expects this will conceal tires, wheels and axles.
4. All utility connections by owner?
(A) Yes. The owner will furnish utility (power, water, septic) connections.
5. Please clarify Leave ready for occupancy as opposed to "but not limited to". Is there anything else expected other than delivery and set- up? setup consisting of Block, Level, tie down and trim out to include H.P. skirting. Who is responsible for the other items it will take to make the unit ready for occupancy?
(A) The successful contractor will deliver unit(s) with all specified equipment, etc, setup (block and level), tie down, and install skirting. The owner will provide and install utilities, any furnishings, personal property or other equipment not specified for occupancy.
6. Will the contractor provide a means of access to the structure (steps, ramp, etc)?
(A) Yes. The successful contractor will provide and install (1) one ADA approved ramp and railing (if required by code) to provide access to the structure.
7. Can the classroom/structure be used?
(A) No. Due to the funding source, this must be a new structure

8. Is the site level and accessible?
(A) The location of the site is the Cherokee Detention Facility (the address is provided in the bid documents) It is a fenced/secure site and access will be coordinated with the Detention Facility staff. The site should easily accommodate the structure, but the final determination as to the fitness of the site is left to the bidder.
9. Do you want poured footings or is ABS pad foundations acceptable?
(A) ABS pad foundations are acceptable
10. If this is a new building do you want us to option overhangs?
(A). Yes. Please show an option in your bid for the cost of 12" overhangs
11. Do you have a floor plan?
(A) Yes. The basic floor plan is attached to this amendment (see below).
