### ***Questions / Answers***

Q. Do you have schematics on how you needs these panels wired internally or is to just mimic all connection points

*A. Wiring Schematics/print file are furnished (as an attachment) with this amendment*

Q. Do you have a specification on the terminal blocks, IE: Make, type etc..?

*A. This is covered in the print file*

Q. On page 17 of the RFB Part number 3SU1400-1AA10-1BA0 is listed twice one for a quantity of 6 and then a quantity of 18 listed, I wanted to verify this not an error?

*This is not an error. It is two separate locations in the panel*

Q. On page 17 under the Notes section it states powered outlets provided by SCC, do you know how long you need the power whips to be?

*A. 48”*

Q. Will SCC accept an “approved equal” panel/enclosure?

*A. SCC will accept an “approved equal” panel/enclosure. The substituted enclosure must be the same size and configuration as the specified enclosure. If there is a question as to fitness of purpose, SCC in its sole discretion will make the final determination.*
