Amendment No. 1

Questions / Answers

1. Will Spartanburg Community College consider changing the term of the contract from a one (1) year contract with four (4) one (1) year renewal options to one (1) five (5) year contract due to the cost and availability of equipment as a result of current economic conditions?

Answer: No. It is the intent of SCC to remain in the contract for each of the five (5) one (1) year terms but will retain the annual renewal intervals.

2. Who is the current service provider at each location? Are any of the listed services currently being subcontracted?

Answer: Waste Management is the current service provider at all locations. SCC is not aware of any subcontractor performance.

3. What are the monthly rates for the services listed at each location?

Answer: The current cost data is not relevant to this solicitation

4. How often is the trash compactor serviced per month at the Campus Operations building on Giles Campus? An estimate is fine.

Answer: The service interval is every other month except in times of high volume at which time it is serviced monthly.
