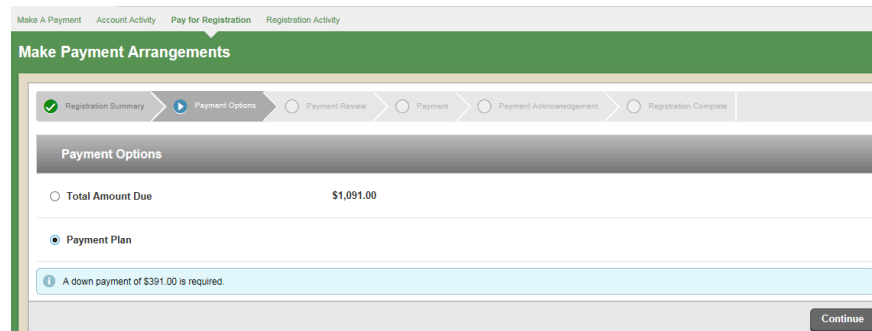
2 ways to sign up within Plan & Schedule:



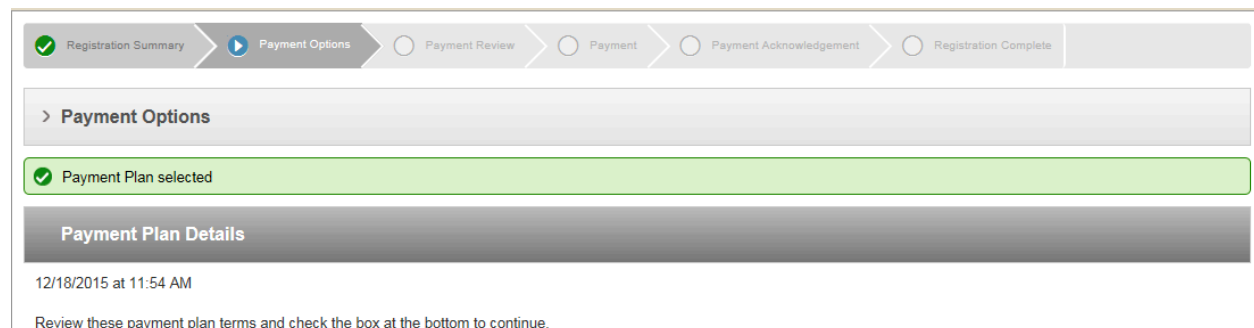
Or within Student Finance: select Pay for Registration:

**Payment Plan Terms and Conditions**

Student: By processing a course registration via the web a student acknowledges they have read and agree to the following terms and conditions. Registration constitutes a financial agreement between you ("Student") and Spartanburg Community College. Tuition, fees and other charges you incur, including but not limited to bookstore charges ("Charges"), shall be added to your student account and are considered a loan for educational benefit. Once you formally register for classes, you assume the responsibility for understanding the College's official policies concerning schedule changes, satisfactory academic progress and the financial policies of the College as described in the "Spartanburg Community College Catalog" for the term of enrollment. SCC will assess a \$25 return check charge in the event a check is returned. You are responsible for all dishonored payments presented on your behalf. SCC will turn over any returned check to the collector's office for collection. Payment requirements not met by published due dates will result in disenrollment from any and all classes. Charges left unpaid for prior terms will result in the inability to register in current term courses unless payment arrangements are made with the College's Business Office. A hold will prevent future registration, graduation, and access to transcripts. If you enroll for a later semester prior to the enrollment hold being placed on your account, your enrollment is subject to cancellation if your balance is not paid to current. Any debt owed after you have left the College may be turned over to an external collection agency. You agree to pay any collection charges incurred by the College, legal costs, and attorney fees. You consent to allowing the collection agency to attempt to contact you on any phone number you have provided or they may have received. You also understand they may use auto dialers to make such contact. This may result in endangering your credit rating on a local or national level. The College will also exercise the right to utilize the South Carolina Department of Revenue's State Tax Refund and Wage Garnishment Programs. You are responsible for any
